Anti Ragging Committee

Maharashtra Prohibition of Ragging Act, 1999 (Maharashtra Act No XXXIII of 1999) "Ragging" means display of disorderly conduct, doing of any act which causes or is likely to cause physical or psychological harm or raise apprehension or fear or shame or embarrassment to a student in any educational institution and includes-

- > Teasing, abusing, threatening or playing practical jokes on, or causing hurt to, such student; or
- Asking a student to do any act or perform something which such student will not, in the ordinary course, willingly, do.
- > Ragging within or outside of any educational institution is prohibited.
- ➤ Whoever directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution shall, on conviction, be punished with imprisonment for a term which may extend to two years and shall also be liable to a fine which may extend to ten thousand rupees.
- ➤ Any student convicted of an offence under section 4 shall be dismissed from the educational institution and such student shall not be admitted in any other educational institution for a period of five years from the date of order of such dismissal.

In view of the directions of the Honorable Supreme Court in SLP No. 24295 of 2006 dated 16- 05-2007 and in Civil Appeal number 887 of 2009, dated 08-05-2009 to prohibit, prevent and eliminate the scourge of ragging, in exercise of the powers conferred under Section 23 read with Section 10 (b), (g), (p) and (g) of AICTE Act, 1987, the All India Council for Technical Education has notified regulation for prevention and prohibition of ragging in AICTE approved technical Institutions vide No. 37-3/Legal/AICTE/2009 dated 01.07.2009. These regulations are accepted by VBKCOE, Malkapur.

Functions:

- 1. To display the charts and other material stating evil nature, punishment of ragging and also student's discipline.
- 2. To create cordial and free atmosphere.
- 3. To involve seniors and fresher's jointly in value based cultural and other activities.
- 4. To entrust the responsibilities jointly.
- 5. To interact with students and casual warning.
- 6. To ensure the spot solutions by adapting soft measures. In case of need, report to the nearest police station.

Procedure:

- 1. The member secretary, in consultation with the chairman of the committee, prepares a provisional agenda for meeting.
- 2. It is circulated to all members of the committee before meeting.
- 3. All the decisions are taken on the basis of majority.
- 4. After the meeting, the committee approves a report embodying its views, recommendations and decisions.

Frequency of Meeting: The committee meets twice in a semester and such other times, if required.
