## **Facility Assess Policy**


#### Following is the process of feedback on facilities.

- 1) Feedback collection process
- 2) Feedback analysis
- 3) Corrective measures

#### 1) Feedback collection process

A standard procedure for feedback on facilities is used by the committee which is appointed by the Principal to take feedback on facilities by using following procedure:

- 1. The Committee collects the feedback from the students on the facilities available in the college such as class room, library, medical facilities, sports, computing facilities, Training and placement, drinking water, internet facility, etc.
- 2. The feedback is analyzed and the necessary corrective measures are implemented after discussions with the Principal.



#### 2) Feedback analysis

The feedback given by the students is consolidated and analyzed by committee and discuss with the Principal about the consolidated report with the management and come out with necessary actions.

#### 3) Corrective measures

- i. Feedback Committee analyzes the feedback and submits the analysis report to Principal.
- ii. Principal takes the necessary corrective measures against those facilities which getting poor feedback and implement it.
