GOVERNING BODY OF INSTITUTE

Composition:

- The Governing Body should have at least eleven members including the Chairman and the Member secretary. The Register Trust/Society/ Company nominate six members including the Chairman and Member – Secretary and the remaining five members are nominated as indicated below.
- Chairman to be nominated by the Register Trust/Society/ Company. The Chairman of Governing Body preferably be either a technical person or an entrepreneur or an educationalist or depute the person who is interested in development of technical education and should show an interest in promoting of quality education.
- Two or five Members are nominated by Registered Trust/Society/Company.
- An industrialist/technologist/educationist from the region is nominated by the concerned Regional Committee as nominee of the council, out of the panel approved by the Chairman.
- Nominee of the state Government /Director of Technical Education (Ex-officio)
- An Industrialist / educationist from the Region is nominated by the state government.
- Principal/Director of the concerned Technical Institution (as nominee of the Trust/Society/company) - Member secretary.
- Two faculty members are nominated from amongst the regular staff.
- The faculty members can be increased equally by adding nominees of the registered Society and by adding an equal number of educationists from the region keeping in view the interest of the technical education.

Functions and Responsibilities of Governing Body

- To represent all members and make sure they can participate heard, create vision; negotiate and maximize self-determination.
- To set overall direction, purpose, future strategies, goals, ethics and values.
- To develop polices and governance arrangements interact with management, steer relationships, alliances and collaborations with the public and among stakeholders.
- To ensure the organization is accountable, legal and financially stable, hire, support and oversee the performance of the top manager; monitor overall outcomes.
